

SUMMARY

- The Offer Price has been determined at HK\$1.20 (excluding brokerage of 1.0%, SFC transaction levy of 0.0027% and the Stock Exchange trading fee of 0.005%)
- Based on the Offer Price of HK\$1.20, the net proceeds from the Share Offer to be received by the Company, after deduction of the underwriting fees and commission and the estimated expenses borne by the Company in connection with the Share Offer, are estimated to be approximately HK\$74.0 million.
- A total of 20,321 valid applications pursuant to the Public Offer on WHITE and YELLOW Application Forms and through giving electronic application instructions to HKSCC via CCASS and under the HK eIPO White Form service (www.hkeipo.hk) for a total of 12,719,805,000 Public Offer Shares were received, representing approximately 1,017.6 times of the total number of 12,500,000 Public Offer Shares initially available for subscription under the Public Offer.
- As the number of Offer Shares validly applied for under the Public Offer is 100 times or more of the number of Offer Shares initially available under the Public Offer, the re-allocation procedure as described in the paragraph headed "Reallocation" under the section headed "Structure and Conditions of the Share Offer" of the Prospectus has been applied.
