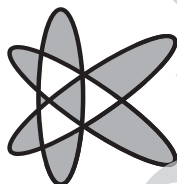

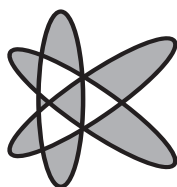

If, for any reason, the Offer Price is not agreed between the Company and the Sole Bookrunner and Lead Manager (for itself and on behalf of the Underwriters) by 12:00 noon on Thursday, 11 May 2017, the Share Offer will not proceed and will lapse.

Applications for Public Offer Shares will not be processed and no allotment of any Public Offer Shares will be made until the application lists close.

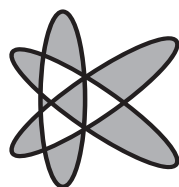
